Established in 2009, the Sustainability Committee is the highest governing body for sustainability at the University.



Governance across the university

- **Sustainability committee**
 - Reports to the Vice Chancellors Executive (VCE) and is the highest governing body with responsibility to promote and coordinate sustainability initiatives across all areas of the University.
 - RMIT Sustainability Committee was expanded to provide direction as a coordinating unit for the SDGs across the University, creating a common narrative and enabling mechanisms to further the SDGs in L&T, research, operations and engaged partnerships.
- **SDGs Working group**
 - To advise RMIT on its approach to address and implement the UN 2030 sustainable development agenda across all areas of the University.
 - To discuss priorities and implement actions to promote and coordinate SDGs activities across the university to maximise SDG influence and impact.

Main key learnings, challenges and recommendations
